A RESOLUTION AMENDING RESOLUTION 2015-12 ADOPTED FEBRUARY 10, 2015 AUTHORIZING THE CITY MANAGER TO ACCEPT THE EXPANDED PROPOSAL AND ENTER INTO AN AGREEMENT WITH KROCK ESSER ENGINEERING, INC., (KEE) FOR THE PROVISION OF DESIGN SERVICES RELATING TO THE OKLAHOMA AREA WATER LINE REPLACEMENT AND PAVING PROJECT AT A COST NOT TO EXCEED ONE HUNDRED AND ONE THOUSAND FOUR HUNDRED FORTY ONE AND 13/100 DOLLARS (\$101,441.13)

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF HURON, OHIO:

SECTION 1. That the City Manager is authorized and directed to accept the expanded proposal and enter into an agreement with Krock Esser Engineering, Inc, for the provision of Design Services relating to the Oklahoma Area Water Line Replacement and Paving Project at a cost not to exceed One Hundred and One Thousand Four Hundred Forty One and 13/100 Dollars (\$101,441.13) which agreement shall be substantially in the form of Exhibit "A" attached hereto and made a part hereof.

SECTION 2. That this Council hereby finds and determines that all formal actions relative to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council and of its Committees, if any, which resulted in formal action, were taken in meetings open to the public in full compliance with applicable legal requirements, including O.R.C. §121.22.

SECTION 3. That this Resolution shall be in full force and effect from and immediately after its adoption.



Authorization to Proceed

- Client shall sign "Authorization to Proceed" for this contract and any/all contract modifications
- Proposal shall expire 90 days from proposal date, unless contract is signed and authorized prior

Invoicing & Payments

- Invoices shall be submitted for payment at project milestones or at 4 week intervals
- Invoices shall be paid within 30 days or finance charges will be applied to the account
- In the event that legal action must be taken to collect unpaid invoices, all costs associated with the collection process, including legal fees, court costs, etc., shall be borne by the client.

Limit of Liability

- In recognition of the risk/reward associated with this contract, the maximum liability of KEE will be limited to the amount of the total price proposal, or \$25,000, whichever is less
