# ECONOMIC DEVEDLOPMENT SCOPE OF SERVICES For The City of Huron

**December 20,2016** 



### SCOPE OF SERVICES:

Juniper CRE Solution's (Juniper) role will be to serve the City of Huron as its Economic Development Advisory firm. In this role, Juniper, will give professional advice, serve as an advocate, and work to attract investment into the community with the goal of making Huron a better place for its residents and businesses. Juniper will perform the following scope of services:

### **Business attraction and retention**

Using the tactics and programs outlined below, Juniper will develop an overall strategy and implementation program to attract new business and retain existing business for the City of Huron

Direct economic development initiatives

Juniper will provide assistance in the creation of short and long term economic and community development plans, as well as the gathering of information and preparation of studies, reports, contracts, documents, and recommendations to achieve City goals. This will involve the preparation and maintenance of information on utilities, taxes, zoning, entitlement, transportation, community services, financial tools, and incentives, in order to respond to requests for information. Additionally, Juniper will assist with the negotiation and management of professional service contracts, property sales or acquisition, and other economic development negotiations, as needed.

Create and Maintain a portfolio of available properties

Juniper will build a data base of buildings and sites in the community. This data base will be promoted to and shared with potential investors and be used to match buyers and sellers. The goal of promoting this catalog of properties is for the sale of sites and buildings and the development of projects within the City.

Translate and market community's attributes into the language of developers and site selectors Juniper will highlight the selling points of The City and create materials and information that will encourage capital/economic investment to be made. Special focus will be given to the marketing of assets and properties in the City. Juniper will also work with a vendor to create and maintain a highly professional website that will carry out a campaign which facilitates economic development through social media, public relations, and other digital avenues.

Implement strategic initiatives

Juniper will coordinate and support special projects regarding historic properties, brownfields, green scaping projects, main street programs, industrial parks, downtown developments, and other economic development initiatives.



Serve as an economic development liaison

Juniper will provide information and/or make presentations to supervisors, councils, boards, commissions, civic groups, businesses, individuals, and the general public on economic development issues, programs. Services, and plans. Juniper will also facilitate and coordinate events such as fam tours, site visits, groundbreaking ceremonies, ribbon cutting ceremonies, and other public relations events that involve economic development.

Conduct outreach to the business community

Juniper will develop a list of prospective businesses (local, regional, and national) in targeted industries. Juniper will also act as primary contact for businesses seeking information regarding opportunities to locate or expand operations in Huron providing tours of potential sites and any other information or assistance as needed.

**Build economic development relationships** 

The Provider will leverage existing relationships with local, state, and federal organizations to facilitate a more economic development friendly environment for the City. In this liaison role, Juniper will work closely with these entities to identify areas of concern in the promotion of business location and expansion within the City. Connections that will be vital for the City include, but are not limited to, Huron Chamber of Commerce, Erie County, Team NEO, Cleveland Plus/Greater Cleveland Partnership, and JobsOhio.

## **Grant administration**

Juniper will maintain a listing of state and federal grant opportunities for economic development initiatives and pursue any relevant ones. Juniper will also assist in the preparation of grant proposals and applications.

**Economic trends updates** 

The Provider will act as Huron's research provider. Juniper will ensure that both digital and printed material will have the most recent information available. Research will be performed on an ongoing basis to confirm data is retrieved from the most relevant and accurate sources. Research related to economic trends, demagogic changes that impact economic development and industry/company dynamics that effect Huron's ED strategy will be provided on a regular basis.



Project management oversight

The Provider will act as project manager on any number of tasks and initiatives that are deemed necessary and advisable by the City, including, but not limited to:

- · Website update and enhancement
- Development of social media campaign
- Creation of a public relations strategy and campaign
- Trade association strategy
- · Facilitation and support liquor license process
- Develop a strategic relationship with Norfolk and Southern RR
- Coordinate the development of the "open air market" concept at the Showboat site
- Support the marketing of the Huron Industrial park
