
A RESOLUTION AUTHORIZING AND DIRECTING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH NORTH AMERICAN SALT CO. FOR ROAD SALT

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF HURON, OHIO:


SECTION 1. That, the City having advertised for bids for road salt with North American Salt Co. being the lowest and best bidder, the City Manager shall be, and he hereby is, authorized and directed to enter into an agreement with North American Salt Co. for the purchase of road salt at the price of \$36.96 per ton for dump truck delivery.

SECTION 2. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Ohio Revised Code Section 121.22.

SECTION 3. That this Resolution shall go into effect and be in full force and effect from and after the earliest date allowed by law.

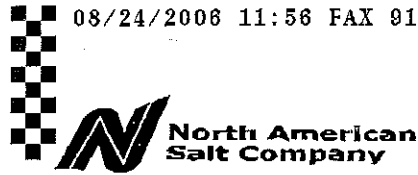
