

RESOLUTION NO. 2019-60

Introduced by Trey Hardy, Mayor

A RESOLUTION APPROVING THE CITY MANAGER'S APPOINTMENT OF BENJAMIN G. CHOJNACKI AS LAW DIRECTOR OF THE CITY OF HURON.

WHEREAS, Resolution 2019-21, adopted April 9, 2019, authorized the City Manager to enter into a Contract with Walter Haverfield LLP for the provision of Law Director services for a period of three years (the "Contract");

WHEREAS, Aimee Lane has acted as Law Director for the City of Huron pursuant to the terms of the Contract through the date of her resignation on October 31, 2019;

WHEREAS, Benjamin G. Chojnacki, an attorney-at-law employed by Walter Haverfield LLP, is admitted to practice before the Supreme Court of Ohio and in good professional standing; and

WHEREAS, the City Council of the City of Huron finds that it is in the best interest of the City and the residents of the City to approve the appointment of Benjamin G. Chojnacki as Law Director, now therefore,

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF HURON, OHIO:


SECTION 1. The Huron City Council approves the appointment of Benjamin G. Chojnacki as Law Director of the City of Huron.

SECTION 3: This Resolution shall be in full force and effect from and immediately following its adoption.




