RULES AND REGULATIONS OF PEDDLERS, SOLICITORS AND CANVASSERS

HOURS

All business done under a license issued by the City of Huron, Ohio shall be conducted between regular business hours of any given day of the week.

This shall not prohibit any licensee from conducting business during hours otherwise prohibited when calling at the residence of a customer by appointment.

POSSESSION AND EXHIBITION OF LICENSE

Any licensee engaged in business within the City shall carry the license and shall produce it for examination whenever requested by any police officer or by any prospective purchaser.

HARASSING OR ANNOYING PROSPECTIVE CUSTOMERS/TRESPASS:

No peddler shall annoy or harass any person by importuning such person to purchase or to look at goods or wares; nor shall any peddler enter any private house or residence without being invited to come in.

REVOCAION OF LICENSE

Any license issued hereunder may be revoked at any time, should the person to whom it is issued be guilty of violating state law or provisions of the City Ordinances or of any fraud, misrepresentation or unlawful act in connection with his/her business.

PENALTY

Whoever violates any of the provisions of this Chapter is guilty of a misdemeanor of the first degree. Each sale or attempted sale made by any person in violation of the provisions of the Code shall be deemed a distinct and separate offense.
