
A RESOLUTION AUTHORIZING THE CITY MANAGER, ON BEHALF OF THE CITY OF HURON, OHIO, TO SUPPORT THE REQUEST OF THE HURON PLAYHOUSE, INC., FOR THE PLACEMENT OF EVENT SIGNAGE IN THE MEDIAN AREA PROMOTING THEIR 2017 SEASON

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF HURON, OHIO:

SECTION 1. The City Manager is authorized on behalf of the City of Huron, Ohio to support the request of the Huron Playhouse, Inc., to place advertising signage in support of their 2017 season in the median area from June 3, 2017 through August 1, 2017, said request to be substantially in the form of Exhibit "A" attached hereto and made a part hereof.

Sign Approval Request for The Huron Playhouse, Inc.


Dear Mr. White and the Huron City Council:

The Huron Playhouse, Inc. respectfully requests approval for the continued usage of signs placed both in front of McCormick School (325 Ohio St.) and within the grassy median East of the traffic light at Center St. and Route 6 East. This is temporary signage which will be in place during our eight-week production season, beginning approximately June 3, 2017 and will be removed by August 1, 2017.

The signage or banners that will be used will be no larger than the signs we have been placing in the median for years and specifically approved by Council the past 10 years. They will be designed and built in accordance with the City of Huron signage specifications.
