

RESOLUTION NO. 2018-66

**A RESOLUTION AUTHORIZING THE CITY MANAGER TO AWARD THE BID AND ENTER INTO AN AGREEMENT WITH SMITH PAVING AND EXCAVATING FOR LABOR AND MATERIALS RELATED TO THE 2018 ROAD PAVING PROGRAM (PART 1) IN AN AMOUNT NOT TO EXCEED FIVE HUNDRED NINETY FOUR THOUSAND SIX HUNDRED NINETY NINE AND 25/100 DOLLARS (\$594,699.25)**

**BE IT RESOLVED BY THE COUNCIL OF THE CITY OF HURON, OHIO:**

**SECTION 1.** That the City having advertised for bids in connection with the 2018 Road Paving Program, this Council finds Smith Paving and Excavating, to be the lowest and best bidder for such work. Therefore, the City Manager shall be, and he hereby is, authorized and directed to award the Part 1 (Rye Beach neighborhood) Base bid and enter into an agreement with the said Smith Paving and Excavating, for undertaking the work called for in the 2018 Road Paving Program -Part 1 bid package, in an amount not to exceed Five Hundred Ninety Four Thousand Six Hundred Ninety Nine and 25/100 Dollars (\$594,699.25), which agreement shall be in substantially in the form of the 2018 Road Paving Contract on file in the office of the Clerk of Council.

**SECTION 2.** That this Council hereby finds and determines that all formal actions relative to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council and of its Committees, if any, which resulted in formal action, were taken in meetings open to the public in full compliance with applicable legal requirements, including O.R.C. §121.22.

**SECTION 3.** That this Resolution shall be in full force and effect from and immediately after its adoption.

- o The Engineer's Official Estimate of Probable Cost for *Part 2* (Village Green) Base Bid is \$ 433,285.
- o The Engineer's Official Estimate of Probable Cost for *Part 2* Portland/Brunswick) Bid Alternate #1 is \$ 214,745.
- o The Engineer's Official Estimate of Probable Cost for *Part 2* (Beachside/Gateway) Bid Alternate #2 is \$ 260,805.
- o The Engineer's Official Estimate of Probable Cost for *Part 2* (Hawthorn, Ironwood, Magnolia, Waterworks) Bid Alternate #3 is \$ 86,470.
