
**A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT FOR THE EXTENSION OF SERVICES WITH REPUBLIC SERVICES INCORPORATED FOR THE PERIOD OF APRIL 1, 2017 THROUGH JULY 1, 2017**

**BE IT RESOLVED BY THE COUNCIL OF THE CITY OF HURON, OHIO:**

**SECTION 1.** That the City Manager is authorized and directed to enter into an extension of services agreement with Republic Services, Inc., 4005 Tiffin Ave, Sandusky, OH 44870 for the provision of garbage, rubbish, recyclable, yard and green waste collection pickup services for the period of April 1, 2017 through July 1, 2017, which agreement shall be substantially in the form of Exhibit "A" attached hereto and made a part hereof.

**SECTION 2.** That this Council hereby finds and determines that all formal actions relative to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council and of its Committees, if any, which resulted in formal action, were taken in meetings open to the public in full compliance with applicable legal requirements, including O.R.C. §121.22.

**SECTION 3.** That this Resolution shall be in full force and effect from and immediately after its adoption.

**AGREEMENT FOR THE EXTENSION OF SERVICES**

The **CITY OF HURON**, 417 Main Street, Huron, Erie County, Ohio 44839, a municipal corporation in the State of Ohio and **REPUBLIC SERVICES, INC.**, 4005 Tiffin Avenue, Sandusky, Ohio 44870 have an existing Services Agreement for the provision of garbage, rubbish, recyclable, yard and green waste collection inclusive of leaf pickup attached hereto and incorporated herein by reference as Exhibit A.

**WHEREAS**, the current Services Agreement expires on March 31, 2017 pursuant to an extension of services ratified by the Huron City Council on December 27, 2016 in Resolution 2016-104; and,

**WHEREAS**, the City of Huron advertised and received bids on February 17, 2017 for the provision of citywide residential comprehensive refuse and recycling services with Republic Services, Inc. being the sole bidder; and,

**WHEREAS**, the parties mutually desire additional time prior to the commencement of the new program to promote the program and provide for public outreach.

**NOW, THEREFORE**, in consideration of the following mutual agreements and covenants, it is understood and agreed by and between the parties the existing agreement as evidenced by Exhibit A, shall be extended for a period of three (3) calendar months to allow for the City to publicly bid the provision of services provided therein. All terms and conditions of the existing Services Agreement shall extend until and expire upon July 1, 2017.
