2022 Rental Rates/Fees:

- \$ 400 1 day/ \$650 2 days. RENTAL for one field, one or two days per week, one time frame (3-hours; Mon-Thur.) for Season of 4/14/21 - 7/23/21. *(Two days per week maximum per Individual Team)*
- FIELD PREP: \$25. per game; \$250 for Season (4/18/22 - 7/21/22) Monday-Thursday. ONLY
- Saturdays & Sundays ONLY: \$35. per 3-hour time frame—Teams must provide field prep.

INDIVIDUAL TEAM RENTAL INFORMATION:

- Individual Team Rentals available **only for Fabens Field #8 and Field #9.**
- Field rental season is 4/18/22 - 7/21/22; **Mondays through Thursdays.**
- **Two days per week maximum** rental per Individual Team. Teams must provide a completed schedule by April 4, 2022.
- Individual Team Rentals cannot be processed before January 15th of the Season year.
- Rentals are accepted based on receipt date of **completed, signed Rental Form AND \$250 Deposit.** Balance due by April 4, 2022.
- Fields cannot be reserved without completed form and deposit. Balance of field rental fee due by April 4, 2022.
- Basic Field Rental Rates do not include Field Prep—see Rates above.
- Refunds/Rentals subject to conditions on reverse side
- **Field Conditions:** In the case of inclement weather or unsafe playing conditions, the city or its representative reserves the right to deem field unplayable.
- A copy of liability insurance is required in specified amounts.
- Huron Parks RULES & REGULATIONS apply (see *cityofhuron.org*) - **No alcoholic beverages in Huron City Parks.**

TERMS AND CONDITIONS WAIVER RELEASE

GENERAL PROCEDURES

- Before a reservation will be accepted, interested parties must call the Parks & Recreation Department to determine availability and to applicable fees.
- After availability is determined, all reservations must be confirmed in writing on the appropriate forms and payment must be made in advance to the Parks & Recreation Department.
- The City reserves the right to reassign playing field at any time
- The City reserves the right to limit reservations to ensure some “open play” time for the general public.
- Fields shall be open for general public use except when officially reserved. Reserving parties are encouraged to take their confirmation notice to the park with them.
- If the rentee fails to leave the facility clean and sanitary, the Parks Department reserves the right to bill for clean up costs and/or not rent to that party again.
- Should competition over field reservations exist, Huron Based Leagues have priority over Non-Huron Based Leagues for practice games, and tournaments have priority over practice games. League games have priority over league practices. City sponsored events have priority over all other reservations.

Returned Checks

Declined payments/returned checks will result in the removal from program until delinquent fees are paid. Returned checks that are not addressed and corrected within 10 days will be turned over to the Huron Police Department. All payments to correct a returned check must be processed through the Finance Dept.

Refund Policy

- Refunds will be made only under the following circumstances:
- If cancellation is made by March 11.
- A \$5 processing fee will be charged to ALL refunds.
- No weather related refunds will be issued.

All recreation rental rules and policies must be adhered to fully. Non-compliance with the rules will result in the applicant being unable to rent any City facilities for future use. By signing this application, on the previous page, the applicant agrees to adhere to the policies and conditions for rental set forth by the City of Huron and the Parks and Recreation Department. By signing this form, the applicant agrees to, and hereby does, indemnify and hold the City harmless of and from any premise/equipment or the use of the premises/equipment by the applicant’s guests, including all cost of defense against any such claims (including but not limited to attorney fees, expert witness fees and all cost of litigation). By signing this form, the applicant agrees to be bound by the above terms and conditions, to pay fees charged and to pay the cost of repair or replacement of the City of Huron property damaged as a result of the use of the rented facility.
