**A RESOLUTION AUTHORIZING THE CITY MANAGER TO ACCEPT THE STATE PRICING PROPOSAL AND AUTHORIZE THE TRADE IN OF A 2012 BOBCAT E50 EXCAVATOR TOWARD THE PURCHASE OF A 2018 YANMAR VIO55 EXCAVATOR, FOR THE WATER DEPARTMENT, FROM WELLINGTON IMPLEMENT IN AN AMOUNT NOT TO EXCEED TWENTY NINE THOUSAND SIX HUNDRED FIFTY AND 00/100 DOLLARS (\$29,650.00)**


**BE IT RESOLVED BY THE COUNCIL OF THE CITY OF HURON, OHIO:**

**SECTION 1.** That, the City having secured state pricing for a 2018 Yanmar VIO55 Excavator, the City Manager shall be, and he hereby is, authorized and directed to accept the state pricing proposal and authorize the trade in of a 2012 Bobcat E50 toward the purchase of a 2018 Yanmar VIO55 Excavator from Wellington Implement in an amount not to exceed Twenty Nine Thousand Six Hundred Fifty and 00/100 Dollars (\$29,650.00), which purchase agreement shall be in substantially the form of Exhibit "A" attached hereto and made a part hereof.

**SECTION 2.** That this Council hereby finds and determines that all formal actions relative to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council and of its Committees, if any, which resulted in formal action, were taken in meetings open to the public in full compliance with applicable legal requirements, including O.R.C. §121.22.
