A RESOLUTION AUTHORIZING THE CITY MANAGER TO AWARD THE BID AND ENTER INTO AN AGREEMENT WITH PROFESSIONAL ELECTRIC PRODUCTS COMPANY (PEPCO) FOR LABOR AND MATERIALS RELATED TO THE ELECTRICAL SUBSTATION EQUIPMENT PROJECT IN AN AMOUNT NOT TO EXCEED TWO MILLION FIVE HUNDRED THIRTY EIGHT THOUSAND AND 00/100 DOLLARS (\$2,538,000.00)

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF HURON, OHIO:

SECTION 1. That the City having advertised for bids in connection with the Electrical Substation Equipment Project, this Council finds Professional Electric Products Company (PEPCO), to be the lowest and best bidder for such work. Therefore, the City Manager shall be, and he hereby is, authorized and directed to award the bid and enter into an agreement with the said PEPCO, for undertaking the work called for in the Electrical Substation Equipment bid package, in an amount not to exceed Two Million Five Hundred Thirty Eight Thousand and 00/100 dollars (\$2,538,000.00), which agreement shall be in substantially in the form of the Electrical Substation Equipment Contract on file in the office of the Clerk of Council.

SECTION 2. That this Council hereby finds and determines that all formal actions relative to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council and of its Committees, if any, which resulted in formal action, were taken in meetings open to the public in full compliance with applicable legal requirements, including O.R.C. §121.22.

SECTION 3. That this Resolution shall be in full force and effect from and immediately after its adoption.
