
**A RESOLUTION AUTHORIZING THE CITY MANAGER TO AWARD THE BID AND AUTHORIZE THE EXPENDITURE OF FUNDS FOR THE PURCHASE OF WATER TREATMENT CHEMICALS TO BONDED CHEMICALS INC. IN AN AMOUNT NOT TO EXCEED NINETY-SIX THOUSAND FIVE HUNDRED TWENTY AND 00/100 DOLLARS (\$96,520.00)**


**BE IT RESOLVED BY THE COUNCIL OF THE CITY OF HURON, OHIO:**

**SECTION 1.** That the City of Sandusky having advertised for bids on behalf of the City of Huron and other entities, has provided a final bid tabulation indicating the lowest and best bid for each chemical and that based on that tabulation, the City Manager is authorized and directed to award the bid and expenditure of funds for the purchase of 14 Tons of Chlorine (in an amount not to exceed Fifty-Four Thousand Three Hundred Twenty and 00/100 Dollars (\$54,320.00)), 8 tons of Powdered Activated Carbon (in an amount not to exceed Twenty-Four Thousand Three Hundred Twenty and 00/100 Dollars (\$24,320.00)), and 6,000 Gallons of Hydrofluosilicic Acid (in an amount not to exceed Seventeen Thousand Eight Hundred Eighty and 00/100 Dollars (\$17,880.00)) to Bonded Chemicals Inc. in a total amount not to exceed Ninety-Six Thousand Five Hundred Twenty and 00/100 Dollars (\$96,520.00. City of Sandusky bid tabulation is attached hereto as Exhibit "A" and made a part hereof.

**SECTION 2.** That this Council hereby finds and determines that all formal actions relative to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council and of its Committees, if any, which resulted in formal action, were taken in meetings open to the public in full compliance with applicable legal requirements, including O.R.C. §121.22.

**SECTION 3.** That this Resolution shall be in full force and effect from and immediately after its adoption.
