
A RESOLUTION AUTHORIZING THE CITY MANAGER TO ACCEPT THE GRANT AWARD AND ENTER INTO AN AGREEMENT WITH THE OHIO DEPARTMENT OF NATURAL RESOURCES, DIVISION OF WATERCRAFT, FOR A MARINE PATROL ASSISTANCE GRANT FOR THE HURON POLICE HARBOR PATROL PROGRAM IN THE CITY OF HURON IN THE AMOUNT OF THIRTY THOUSAND THIRTY-SEVEN AND 31/100 DOLLARS (\$30,037.31).

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF HURON, OHIO:


SECTION 1. The City Manager is hereby authorized and directed to execute an agreement for and on behalf of the City of Huron, Ohio with the Ohio Department of Natural resources, Division of Watercraft, for a grant to maintain and operation the Huron Police Harbor Patrol Program in the amount of Thirty Thousand Thirty-Seven and 31/100 Dollars (\$30,037.31), which agreement shall be in substantially the form on file with the Clerk of Council.

SECTION 2. That this Council hereby finds and determines that all formal actions relative to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council and of its Committees, if any, which resulted in formal action, were taken in meetings open to the public in full compliance with applicable legal requirements, including O.R.C. §121.22

SECTION 3. This Resolution shall be in full force and effect from and immediately following its adoption.
