
A RESOLUTION AUTHORIZING THE CITY MANAGER TO ACCEPT STATE PRICING AND ENTER INTO AN AGREEMENT WITH STATEWIDE MUNICIPAL LEASING FOR THE LEASE/PURCHASE OF TWO (2) 2017 FORD INTERCEPTOR SUV'S IN AN AMOUNT NOT TO EXCEED SEVENTY SEVEN THOUSAND SEVEN HUNDRED TWELVE AND 21/100 DOLLARS (77,712.21)

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF HURON, OHIO:

SECTION 1. That, the City having secured state pricing for two 2017 Police Vehicles, and have included the 2017 expense within the 2017 municipal budget; the City Manager shall be, and he hereby is, authorized and directed to accept the state pricing and enter into an agreement with Statewide Municipal Leasing, 1108 W. Main Street, Van Wert, Ohio 45891 for the lease/purchase of two (2) 2017 Ford Interceptor SUV's in an amount not to exceed Seventy Seven Thousand Seven Hundred Twelve and 21/100 Dollars (\$77,712.21), which agreement shall be in substantially the form of Exhibit "A" attached hereto and made a part hereof.

SECTION 2. That this Council hereby finds and determines that all formal actions relative to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council and of its Committees, if any, which resulted in formal action, were taken in meetings open to the public in full compliance with applicable legal requirements, including O.R.C. §121.22.

SECTION 3. That this Resolution shall be in full force and effect from and immediately after its adoption.
