SEALED BIDS for the furnishing of the necessary materials and construction of the

**WATER TREATMENT PLANT IMPROVEMENTS
HURON, OHIO**

will be received by the City of Huron, 417 Main Street, Huron, Ohio 44839 until

10:00 a.m. (Local Time)
Thursday, October 17, 2019

and at that time and place will be publicly opened and read aloud.

The scope of work for this project consists of new chains and Flights with drives for five (5) sedimentation basins. Valve and electrical improvements plus alternates including tube settlers in the sedimentation basins and a new building to cover the five (5) sedimentation basins.

The contract documents, including plans and specifications, are on file at the office of the City of Huron, Ohio and the Architect/Engineer -- Poggemeyer Design Group, Inc. (PDG). The documents may be viewed and ordered online or obtained from Becker Impressions, 4646 Angola Road, Toledo, Ohio 43615, Telephone 419-385-5303, www.pdgplanroom.com for the cost of printing to be paid to the printing company at the time the documents are picked up. Shipping and tax charges are the bidder's responsibility and payable directly to Becker Impressions.

The Engineer for the Project is Poggemeyer Design Group, Inc., 1168 North Main Street, Bowling Green, Ohio 43402.

A Pre-Bid Meeting has been scheduled for Wednesday, October 9, 2019 at 10:00 a.m. at the water plant which is located at 500 Cleveland Road West, Huron, Ohio 44839.

All bids must be signed and submitted on the blanks which are bound in this booklet. Bids must state the unit prices in the blanks provided and be enclosed in a sealed envelope marked – **Water Treatment Plant Improvements** --- and addressed to the City of Huron, 417 Main Street, Huron, Ohio 44839.

The bid guaranty may be of two forms:

1. A Bid Guaranty and Contract Bond using the form in the Contract Documents. (The amount of the bid does NOT have to appear on this form.)

2. A certified check, cashier's check or letter of credit in favor of the City of Huron, Ohio in the amount of 10% of the bid. If the contract is awarded, a Contract Bond will be required, which is a 100% payment and performance bond.

This procurement is subject to the EPA policy of encouraging the participation of small businesses in rural areas (SBRAs).

After the award of the contract let by competitive bid and prior to the time the contract is entered into, bidders shall submit the affidavit required under the Ohio Revised Code, Section 5719.042 that the bidder was not charged with any delinquent personal property taxes in Erie County, Ohio.

The successful bidder will be required to pay not less than the highest applicable minimum wage rates as established by the federal Davis-Bacon Wage Determinations issued by the U.S. Department of Labor.

The City of Huron, Ohio reserves the right to reject any and all bids and to waive any irregularity in any bid and to determine the lowest and best bidder.

No bidder may withdraw his bid for a period of 60 days after the scheduled closing time for the receipt of bids. This project is being partially funded with Ohio EPA Water Supply Revolving Loan Account (WSRLA) with Buy American requirements.

The estimated cost of construction is \$2,200,000.
