I responded to Parts Authority on the report they were having trouble with a customer. They further reported the subject drove through their yard causing damage.

I met with Mr. Jared Byrd, counterman, at the parts store. Mr. Byrd described a white male, facial hair, dark hair, and heavysset as being involved. The involved male reportedly had been in the store yesterday, December 3, 2019, to purchase parts. During his interaction with store employee Jacob Stotler, the male had made reference to having more money if he had a gun. He was described by Mr. Byrd as being agitated while in the store. Deep tire tracks were later noticed in the grass (see attached). Mr. Byrd advised they checked video footage and found it was the involved male driving a blue Jeep.

The same male returned to the store today just prior to reporting time. They advised he became increasingly agitated while in the store attempting to purchase additional parts. During this time he was belligerent with Mr. Stotler. Mr. Stotler wrote in a statement

that the male advised, "are you on drugs, do you know what your doing, why the fuck is this taking so long I've been here for over 20 minutes, just hurry the fuck up I need to go to another parts store (sic)." The involved was advised to calm down by Mr. Byrd. He told him to "fuck off" they grabbed his items and left the store. Mr. Stotler followed the male out of the store and wrote down the registration as GWB3829 on a blue Jeep.

Mr. Byrd advised they wished to pursue a criminal damage charge on the male. This was later confirmed when I spoke with the Parts Authority GM of Ohio stores, Michael Derose. They further wished to have the male trespassed from the store. I left statements with Mr. Byrd requesting anyone who witnessed the male's actions to complete a statement.

I found the vehicle registration came back to Ms. Cathy Beaver on a 2006 blue Jeep. I was able to find through an acquaintance of Ms. Beaver's that the involved male driving the vehicle was Mr. David Warner. I had interaction with Mr. Warner and the vehicle on December 3rd, when I noticed the vehicle was parked in front of the entrance to the Rye Beach Hi-Miler, door open, and no-one around. I noticed the vehicle had mud all over it and asked an employee why the vehicle was left there. She advised a male had just entered the store to get a car wash. At that point, I witnessed Mr. Warner exit the store and get back into his vehicle.
