I responded to 320 Orangewood Road in regards to threats made over social media. Upon arrival contact was made with the complainant, Amy LaCivita. Mrs. LaCivita stated that her 14 year old son, Evan LaCivita, received a threatening message from an unknown person last night on Instagram. The message was a direct message (DM) from an unknown person that stated "I'm gonna shoot you".

I spoke to Evan and he stated that he received the DM last night from an unknown person. The name on the account was "Joe123746". Evan stated that the account has since been deleted and the DM conversation has been deleted as well.

Evan stated that several of his friends also received DM's from the same account. Several of the DM's where threatening. He named Evan Collins, Ke'Andre Moore, Brady Petz, and Jack Lesnet as receiving DM's, but did not know what was said in those messages.

Evan stated that yesterday during school (McCormick Jr. High) Devin Neibler was making comments to him during two seperate classes. Evan stated that after he told Devin to stop, Devin stated something to the effect of "I'll kill you" or I'll shoot you". Evan suspects that Devin could be the one that threatened him on Instagram. I told Mrs. LaCivita that myself and McCormick Jr. High School Principal, Chad Carter, will follow-up on this with the involved students at school tomorrow.

I contacted Mr. Carter and advised him of this complaint.
