Dispatch advised a caller had a young juvenile show up at his back door at 402 Leisure Drive and was unsure of where she came from. I arrived at the listed address and met with the caller Mark Faust and his wife Susan Faust. They allowed me to enter their residence where I made contact with the juvenile later identified as Josephine Myers.

Josephine was sitting on the floor playing with a few toys that Mr. and Ms. Faust had given her. Mr. Faust stated she had wandered up to the back door and then made entry. He continued that they looked around the rear of the residence and was unable to see anyone looking for her so he called the police department.

While talking to Josephine I asked where she lived, and her birthday. Josephine was unable to tell me where she lived and only repeated that she was eight (8yrs). Shortly after my arrival, Susan White arrived at the residence and explained that she was Josephine's grandmother. Ms. White stated that Josephine had exited the backdoor of their residence at 412 Leisure Dr. and

wandered off. Ms. White continued that once she noticed Josephine was gone she started looking at the nearby houses. While her husband (Gerald White) drove his truck around the neighborhood. I explained the Endangering Children ordinance to both Mr. and Ms. White to which they stated they understood. I was confident that Josephine was in safe and capable care and returned to service.

Ms. White was able to provide me with Josephine's date of birth and address, along with her parents name and contact phone numbers. Once on station I made contact with Josephine's Mother Jennifer Myers to make her aware of the incident. Ms. Myers stated her mother-in-law (Ms. White) had already contacted her and made her aware. She then expressed her gratitude and hung up.
