Dispatch advised over the phone that they received an anonymous call in reference to a Josh Pence possibly being suicidal and he was staying at 134 Richland Ave. Ofc. Clayman and I responded to Richland Ave and made contact with Josh's father, Larry Pence. Larry told us that Josh was not living at the house but he does sometimes. I advised him that we received an anonymous call to check on Josh and that he may be suicidal. Larry said he does not think this would be true as he spoke with Josh a couple hours ago. He said the caller is probably his daughter Stormy, who has been causing some family issues lately. He called Josh at 567-201-5194 and I could hear Josh say, "Stormy must have called." I spoke with Josh and he told me he was not suicidal and that Stormy has been causing some issues. Josh assured me he was not suicidal and that he would call Stormy to let her know everything was fine. All was quiet upon departure.
