Officers responded along with Huron Fire to 533.5 apartment B for a possible overdose. Upon our arrival contact was made with Chris Beddingfield and his girlfriend Bianca Mallotti who were standing outside on the sidewalk. I spoke with Ms. Mallotti and Chris's father David Beddingfield inside the apartment while Officer Orzech remained outside with Chris and squad personnel. David said Bianca woke him up and said she thought Chris was overdosing. Bianca said Chris was slumped over and she had difficulty waking him up so she assumed he was overdosing and woke his father up. Chris told Officer Orzech he was sleeping and the next thing he knows his dad and girlfriend were shaking him trying to wake him up. He stated he was not overdosing and agreed to let the squad check him out. All of Chris's vitals were normal and squad personnel advised he seemed fine. Nothing further was needed and all units returned to service.
