I was traveling EB on US6 crossing the SR2 overpass when I observed a vehicle operating near the playground area of Fabens Park. I entered the park and observed the vehicle, 2015 Dodge 4s, Ohio RP-HPY6464, travel off of the sidewalk area and back into the parking lot. I initiated a traffic stop on the vehicle, with several subjects who were in the playground area began to run away from our location, while 2 others remained in the area.

I made contact with operator of the vehicle, Michael Lewallen, and advised him for the reason of the stop. I also made contact with Michael's 2 friends who did not run, and advised them to contact the others and have them respond back to our location.

A short time later, Mason Luipold, Jacob Detlor, Abby Miller, and Claire Solberg responded back to our location. They were spoken to about the possible consequences of their actions. A parent for each of the juveniles were contacted and advised of the complaint.
