While assigned as the School Resource Officer, I was at Huron High School when a student, who wished to remain anonymous, advised me that they suspected that Tony (Anthony) Pendergrass was in possession of marijuana. The student showed me a text conversation between them and another student where the other student tells them that Pendergrass had a bag of marijuana in his backpack. This information was passed on to the schools Principal, Tim Lamb. As Principal Lamb was out of the building he allowed us to talk to Pendergrass.

Det. Jacobs, who was already at the school for a separate investigation, and I spoke with Pendergrass and advised him of the complaint. Pendergrass immediately admitted to being in possession of a bag of marijuana, approximately 2 grams. He stated the marijuana was in his backpack and the backpack was in his locker.

Mr. Steve Camella, the schools Athletic Director, responded to Pergrasses locker and took possession of the backpack. In the

presence of myself, Det. Jacobs, and Mr. Camella, Pendergrass showed us where the marijuana was at in his backpack. At that time Mr. Camella removed a medium sized box. Inside the box was a small plastic bag containing suspected marijuana (later weighed at 3.84 grams), two packages of rolling papers, and a lighter. All the items were turned over to Det. Jacobs by Mr. Camella.

Pendergrass was advised that he would be charged with possession of marijuana and possession of drug paraphernalia. He remained in the custody of the school. The confiscated items were later logged into and secured in evidence by Det. Jacobs. The charges will be completed and forwarded to the Erie County Juvenile Court.
