Shawn and Lynn advised after allowing Jacquelin in their home, she disrespected them by going to hang out with the above mentioned friends. Shawn and Lynn advised Jacquelin is no longer welcome in the home. They then shut their door and requested Jacquelin leave their property. Jacquelin left the area but wished for the incident to be documented. I informed her she would need to
