I acked Anth	ony where he was	driving too and he claimed home to Vermilion, Lacked

I asked Anthony where he was driving too and he claimed home to Vermilion. I asked him where he had left from and he said Amherst. I asked him if he knew where he was and he said no. I asked Anthony for his driver's license, he fumbled through his wallet and retrieved it for me. I then asked him to step form the vehicle. As he stepped from the vehicle, he had to use the door for support and dropped his wallet in the process. When he bent over to pick up the wallet, he had to take a stagger step to maintain his balance. Anthony was walked to the area between his car and my cruiser. I requested that he submit to some field sobriety tests to determine his ability to safely operate a motor vehicle, he refused all the tests offered. At that point, I placed Anthony under arrest for OVI. He was handcuffed (behind the back and double-locked) and secured in the rear of Cruiser #8 for transport on station. Ofc Vogel remained on scene with the vehicle until it was towed by Sandusky Towing.

I transported Anthony on station. Once on station, he was advised of his rights via the "Your Rights" form to which he acknowledged with his signature. In checking Anthony's driving record, I noticed that he has a prior OVI conviction through the Vermilion court in 2018. I provided him with a copy of the BMV Form 2255 and requested that he read along as I read the Consequences of Test and Refusal section. Once I was completed, I advised Anthony that I would be requesting a sample of his breath to which he again advised he was going to refuse the test. I advised Anthony of the Notice of Suspension and Immobilization or forfeiture section on the form as well.
Anthony's behavior once on station was belligerent and uncooperative. He constantly needed to be told to calm down and he would be released when the process was completed. Anthony was issued citation #32829 for Driving upon a Divided Roadway (MM), OVI (M1) and OVI-Refusal with prior conviction (M1). He was allowed to sign a recog bond conditional on his appearance in the Huron Municipal Court on 6/11/19 at 0830 AM. Due to his state of Intoxication and belligerent behavior, no fingerprints or mug shots were taken at the time of the arrest. He was released to Shauna Boden.
