I was dispatched to Faben's Park in reference to a possible dog bite complaint. When I arrived, I made contact with Lori A Ferenczy who advised her son, William J. Ferenczy (age 9), was injured by a loose dog. Mrs. Ferenczy showed me her son's right leg which has several scratches causing bleeding. William advised he was at Field #6 attending a baseball camp when a dog attacked him while running to first base. He stated the dog attempted to bite him, however, he believes the dog scratched him causing his wounds. Mrs. Ferenczy advised the wounds did not appear to need medical attention. William described the dog as a large black dog, possibly a lab.

It was later learned that the owner of the dog was R. Tom Gimperling. I made contact with Mr. Gimperling and advised him of the complaint which he was aware of. He stated his dog is a black in color five year old female Doberman Pinscher with a valid dog license and up-to-date shots. He continued that his dog is an overly aggressive playful dog who is too rough at times, however,

means no harm. He advised that he had the dog on a leash tied to a drinking fountain which the dog got loose and chased the young boy who was running the bases. He was advised a report would be on file and he was warned for dog running.

I re-contacted Mrs. Ferenczy and advised her of my conversation with Mr. Gimperling. She stated that she transported her son to the Cleveland Clinic Express Care to be checked. She advised everything was fine and to verify the dog has current vaccinations. Mr. Gimperling advised he would contact Mrs. Ferenczy directly.
