On 12 JUN 2019 13:06 Hours, OFC Vogel and I responded to 307 Kiwanis Avenue for a report of a sick raccoon at the location. Upon arriving, we met with the complainant, Gretchen Pisano, who stated that a small raccoon was hiding in her neighbor's landscaping, and she was concerned it may be sick. Pisano stated that she first saw the raccoon in the street, after which it scurried into the foliage.

The raccoon appeared to be young and was missing an ear. The raccoon did not appear sick however and seemed to be acting normally. I advised Pisano that the raccoon would not be euthanized. I also called "Back to the Wild" who advised that they do not rescue raccoons. They referred me to an organization out of Fostoria, however, their voicemail indicated they were currently not rescuing orphaned wildlife. Pisano was advised of my findings and was encouraged to call if she notices signs that the animal is
