On 02 JUL 2019 13:24 Hours, Dispatch advised of a request for a welfare check on a male subject. The male, described as wearing a red shirt, had walked into Family Eye Care and told staff he had injured his hand. The male asked if he should go to the hospital to have the injury treated. The staff advised he should and the male stated that he was going to go next door to a friend's house. While in the parking lot, the male passed out for twenty seconds and then got up and walked across the street after getting a dog from his car.

The car was located in the parking lot, and was found to be a black Ford Focus bearing Ohio Registration GWS4286. The male was located at 313 Williams Street, and was identified as Giovanni James. James had what appeared to be a blunt force injury to the top of his right hand, which was swollen. James advised he had injured the hand punching a wall yesterday. After confirming with
