I responded to 551 Cleveland Rd W. Apt. C for a Telecommunications Harassment. Upon my arrival I met with Amber Vanlowe. Vanlowe advised that she had now received more harassing text messages from her ex-boyfriend Jonathon Toth. Toth was previously warned via phone not to have any contact with Vanlowe (See report 20191097). Vanlowe showed me several messages from that day and night before from Toth which were harassing in nature. Vanlowe wished to not be bothered any further by Toth, and was concerned what he might do if she returned back to the residence for her belongings.

It was determined that Toth would be charged with Telecommunications Harassment. Sgt. Sean Ryan and I responded to his residence. At the residence Sgt. Ryan informed Toth he was being placed under arrest for Telecommunications Harassment. Toth was placed in hand restraints (checked for gap and double locked), searched, and secured in the rear of cruiser #8. Toth was then transported onto station. He was secured to the booking chair. I then completed fingerprints (ITN-101274HU). When attempting
