On 29 AUG 2019 10:50 Hours, Dispatch advised of a private property motor vehicle crash that had been reported at 1023 Main Street. I responded to the scene. The location is the Blue Ribbon Catering business parking lot.

Upon arrival, I met with Peggy Moore. Moore stated that she had backed a white 2014 Ford Transit Connect van (Ohio Registration PIU1005) into another employee's vehicle. The vehicle had been parked behind a van that was parked adjacent to the vehicle Moore was operating. The damage to the van consisted of the right rear bumper moulding popping off and some scrapes to the right rear corner. The van is registered to P J Lindy N Co INC and is insured through Benchmark Insurance Co. #GRBCA500273101.
