Ofc. R. Boesch and I were dispatched to the Rye Beach Hy-Miler for a report of a physical domestic. Members of the Huron Fire Department called it in. They advised that the involved was in a blue in color Ford sedan.

Upon our arrival, we were directed to two separate males. I made contact with a male that was identified as Christopher Roberts that was inside the gas station. Ofc. Boesch spoke to Jonathan Peringer that was sitting inside a blue Ford Focus.

Mr. Roberts told me that there was no domestic situation. He added that the does not know the male in the blue vehicle. According to Roberts, the incident began as a traffic altercation that took place as both were leaving Cedar Point that continued to the gas station. Roberts admitted to confronting the other male about his driving, but quickly added that there were no threats or physical confrontation.

Ofc. R. Boesch advised that Mr. Persinger gave a similar account as Roberts. Both parties did not want the matter pursued and they
