The complainant, Sharon L. Balcarcel, contacted this department via telephone to report a theft that occurred at the Discount Drug Mart parking lot. I spoke to her and she advised the following: According to Balcarcel, she exited Drug Mart at approximately 19:30 hours with a shopping cart. She had her purchases in the cart as well as her tan wallet which was sitting in the front basket. Balcarcel saw a friend in the parking lot and left her cart next to her vehicle with everything still in it. She walked over and spoke to the friend for a few minutes. After returning to her vehicle and starting to exit her parking space, Balcarcel realized that she didn't have her purse. She checked the cart and found it missing. Inside the purse was her Ohio drivers license, Erie Community Credit Union debit card, black Galaxy cell phone, and approximately \$60.00 cash.

I asked Balcarcel if she noticed anyone near her vehicle which was parked approximately three rows from the entrance to the store. She stated that there were two white females with a baby getting into a black car that was parked next to her vehicle. Balcarcel could

not provide any description other than they were ordinary looking. She did add that she was able to locate her phone on the internet and it was in the area of 1214 Fifth Street in Sandusky, Ohio. I advised her that a report would be generated and we would investigate the theft. She was also encouraged to cancel the debit card as soon as possible.

Ofc. L. Bethard responded to Drug Mart to view any video surveillance that they may have. There are no cameras that point toward the parking lot. There is a camera that records everyone entering Drug Mart. At approximately 19:12 hours two females are seen entering the store with a small child. One of the females is described as being thin, dark hair that was pulled up into a bun, with eye glasses, a black tank top, and black sweat pants. The other female holding the child is described as being heavier, dark hair that was pulled up, and she was wearing a Cavs t-shirt. At this time Drug Mart was unable to download the footage. They will contact IT in the morning so that it can be given to us.
