Sgt. Ryan and I responded to the listed address on the report of a domestic violence incident. Dispatch advised a son was punched by his father there.

Upon arrival, I was met by Ms. Billie Jo Killbride. She pointed out John and Justin Killbride who were in a bedroom. Everything was relatively calm, and I requested the parties separate. Justin stood by in his bedroom and spoke with Sgt. Ryan while I spoke with John, Billie Jo, and Hallie in the kitchen.

John started out by saying his son is under a lot of stress. As far as the incident, he claimed he was asleep in his bedroom when he was awoke by commotion in the kitchen. When he came out he attempted to calm the arguing and had to get between Justin and other family members. They argued and he was eventually able to calm him and was speaking with him in his room just prior to officer arrival. John advised they only time it was physical was when he entended his arms pushing his son back away from other

family members during the argument. He denied striking his son and thought he would only say that to get back at him for a domestic situation a few years ago.

Hallie stated the argument started when Justin came out of his room and drank half of a can of pop. He began yelling about it and calling her vulgar names. During this yelling he also dropped a plate on the ground and shattered it. Hallie reported no violence occurred.

Billie Jo added that she could hear Justin yelling and cursing at a video game in his room prior to the argument. She stated she didn't even want to enter his room so she sent him a picture of a plate of food. When he came out he became angry with his sister and began calling her names and breaking a plate. She reported no violence.

Justin advised Sgt. Ryan he may have been a little worked up from his video game prior to yelling at his sister. He claimed his father punched him on the right side of the jaw during the argument but did not wish to pursue the matter. Sgt. Ryan was unable to see any definite markings that showed Justin was assaulted.

All parties agreed Justin would go to his grandmother's residence for the night to calm down. The Killbride's advised everything would remain calm until he was picked up. They were encouraged to contact this agency if anything further was needed.
