Hallie stated the arguement started when Justin came out of his room and drank half of a can of pop. He began yelling about it and calling her vulgar names. During this yelling he also dropped a plate on the ground and shattered it. Hallie reported no violence occurred.

Billie Jo added that she could hear Justin yelling and cursing at a video game in his room prior to the argument. She stated she didn't even want to enter his room so she sent him a picture of a plate of food. When he came out he became angry with his sister and began calling her names and breaking a plate. She reported no violence.

Justin advised Sgt. Ryan he may have been a little worked up from his video game prior to yelling at his sister. He claimed his father punched him on the right side of the jaw during the argument but did not wish to pursue the matter. Sgt. Ryan was unable to see any definite markings that showed Justin was assaulted.

All parties agreed Justin would go to his grandmother's residence for the night to calm down. The Killbride's advsied everything would remain calm until he was picked up. They were encouraged to contact this agency if anything further was needed.
