While assigned as the school resource officer, I responded to McCormick Jr. High in regards to a report of an assault. Upon arrival, contact was made with the school's principal, Mr. Chad Carter. Mr. Carter explained that 8th grade student Gauge Finlay was brought to the office by two teachers for assaulting a student in class. The student, Seth Abazi, suffered a bloody nose and a mark under his left eye as a result of the assault.

Mr. Carter stated that Abazi was sitting at his desk just prior to the start of class when he was confronted by Finlay. Finlay asked him why he was "talking shit" about him. Abazi ignored him and Finlay asked again. This time Abazi told Finlay that he didn't know what he was talking about. At that time, Finlay punched Abazi several times in the head and face. Mr. Carter stated that Finlay admitted to assaulting Abazi. Mr. Carter also interviewed several students in regards to the assault.

As a result of the assault, I placed Finlay under arrest. He was transported on station and placed in one of the juvenile holding

chairs (handcuffed). I contacted the Erie County Juvenile Justice Center and they directed me to transport Finlay to their facility. I also contacted Findlay's father, Thomas Finlay, and advised him of the incident and that Gauge would be transported to the Juvenile Justice Center. While Gauge was talking on the phone with his father, I heard him state, "I wasn't gonna let him talk shit about me".

Gauge Finlay was charged with one count of assault (M1). Once the necessary paperwork was completed, he was transported to the Erie County Juvenile Justice Center.
