Sgt. Ryan, Ofc. Clayman, and I responded to 535 Cleveland Road West, Apt P, for a report of a female who had cut her wrists. Sgt. Ryan arrived on scene and knocked on the door to apartment P which received no answer. Sgt. Ryan opened the door and announced his presence, again receiving no answer. With the door open, Sgt. Ryan heard a female crying in the bathroom and made contact with her. He located the female, Kierra Rice, with superficial wounds to her left wrist/forearm with multiple knives next to her. He secured the knives away from her possession while Ofc. Clayman and I arrived on scene. Huron Fire responded and transported her to Firelands Regional Medical Center for a mental health evaluation.

Also within the apartment were Ms. Rice's three children, Xayn, Yuself, and Zoelyn were inside the residence as well. Sgt. Ryan contacted Erie County Children's Services and advised them of the situation. The on-call caseworker from Children Services arrived and we transported the three children to the Huron Police Department. After a short time, the Children Services caseworker made
