## **RESOLUTION NO. 2016-69**

A RESOLUTION AUTHORIZING THE CITY MANAGER TO AWARD THE BID AND ENTER INTO AN AGREEMENT WITH DELLINGER EXCAVATING INCORPORATED FOR LABOR AND MATERIALS RELATED TO THE ERI-6-16.73 FABENS PARK MICHIGAN LEFT PROJECT IN AN AMOUNT NOT TO EXCEED THREE HUNDRED FORTY ONE THOUSAND THREE HUNDRED FORTY AND 78/100 DOLLARS (\$341,340.78)

## BE IT RESOLVED BY THE COUNCIL OF THE CITY OF HURON, OHIO:

SECTION 1. That the City having advertised for bids in connection with the Fabens Park Michigan Left Project (ERI-6-16.73), this Council finds Dellinger Excavating Inc., 3691 Horn Road, Monroeville, OH 44847 to be the lowest and best bidder for such work. Therefore, the City Manager shall be, and he hereby is, authorized and directed to award the base bid and enter into an agreement with the said Dellinger Excavating Incorporated for undertaking the work called for in the Fabens Park Michigan Left bid package, in an amount not to exceed Three Hundred Forty One Thousand Three Hundred Forty and 78/100 dollars (\$341,340.78), which agreement shall be in substantially in the form of the Fabens Park Michigan Left Project Contract on file in the office of the Clerk of Council.

SECTION 2. That this Council hereby finds and determines that all formal actions relative to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council and of its Committees, if any, which resulted in formal action, were taken in meetings open to the public in full compliance with applicable legal requirements, including O.R.C. §121.22.

**SECTION 3.** That this Resolution shall be in full force and effect from and immediately after its adoption.
